## 1. Introduction

The second quarter of 2024 witnessed transformative developments in the cryptocurrency Exchange-Traded Fund (ETF) landscape, especially concerning Bitcoin and Ethereum. A series of approvals by the U.S. Securities and Exchange Commission (SEC) and similar regulatory bodies across global financial hubs has opened the door for institutional investment in crypto assets at an unprecedented scale. While Bitcoin ETFs continued to dominate, the quarter saw Ethereum exchange-traded funds enter the spotlight, bringing new opportunities and challenges to the market. The ripple effects of these regulatory decisions are being felt across regions, from Hong Kong's ambition to become a crypto hub to Australia's burgeoning interest in digital assets.

This report provides a detailed account of key developments, market dynamics, institutional engagements, and emerging trends in the crypto ETF sector, focusing on Bitcoin, Ethereum, and other notable digital assets like Solana and XRP. Regulatory updates, market responses, and expert opinions form the backbone of this report, offering a comprehensive narrative for industry stakeholders.

## 2. U.S. Crypto ETF Landscape

## 2.1. Approval of Ethereum ETFs

One of the most significant milestones for Q2 2024 was the SEC's approval of spot Ethereum ETFs. Following the success of Bitcoin ETFs approved in January 2024, the SEC extended its green light to Ethereum, allowing leading exchanges like the New York Stock Exchange (NYSE), Nasdaq, and the Chicago Board Options Exchange (CBOE) to list these products. Issuers including BlackRock, Fidelity, Grayscale, and others are set to launch Ethereum ETFs, enhancing institutional access to Ethereum.

The approval process was notably swift, given the SEC's historical reticence toward cryptocurrencies. This regulatory shift reflects an evolving stance in Washington, potentially driven by growing bipartisan support for digital assets. As a result, Ethereum's price surged 18.2% in the days following the SEC's announcement, further cementing its position in the crypto market. These ETFs are seen as a pivotal moment for institutional investors seeking regulated pathways into Ethereum without the complexities of direct ownership.

## 2.2. Institutional Appetite for Ethereum ETFs

The enthusiasm surrounding Ethereum ETFs is evident from the growing demand among institutional investors. While Bitcoin ETFs have seen inflows of over \$13 billion since their launch in January, Ethereum ETFs are expected to attract similarly high levels of investment, particularly from wealth managers and financial advisers. A VettaFi poll from April revealed that 64% of financial advisers prefer ETFs as the best way to access cryptocurrency markets, with Ethereum being a prime focus due to its real-world applications and extensive user base.

Despite the SEC's rapid approval, regulatory hurdles remain. ETF issuers must file individual registration statements, which could delay the actual trading of these products. Moreover, there are concerns about the risks of widespread adoption, including market volatility and security vulnerabilities. Nevertheless, the overall sentiment is optimistic, with Ethereum seen as a gateway to more sophisticated financial products in the crypto space.



## 2.3. Implications for Other Cryptocurrencies: Solana

The SEC's approval of Ethereum ETFs has led to speculation about the future of other cryptocurrencies. Ripple's XRP and Solana are viewed as potential candidates for spot ETF approval, especially given the precedent set by Bitcoin and Ethereum. Ripple CEO Brad Garlinghouse has expressed concern about the regulatory clarity surrounding XRP, suggesting that an ETF for XRP is "inevitable," though regulatory challenges remain significant. Similarly, Solana, often seen as a competitor to Ethereum, has garnered interest from institutional investors, with asset manager VanEck filing for a Solana ETF.

While the SEC's stance on cryptocurrencies beyond Bitcoin and Ethereum remains cautious, the success of these ETFs could pave the way for more digital assets to gain regulatory approval. Solana, in particular, has shown promise due to its high utility and decentralized nature, with analysts predicting significant price increases if an ETF is approved.



"Based on current precedent/needs, [it] will happen within a few years of getting a CFTC-regulated futures market. # 3. Global Developments in Crypto ETFs

## 3.1. Hong Kong: Asia's Emerging Crypto Hub

In parallel with developments in the U.S., Hong Kong has positioned itself as a major player in the crypto ETF space. The Hong Kong Securities and Futures Commission (SFC) approved Bitcoin and Ethereum ETFs earlier in 2024, and these products have begun trading on the Hong Kong Stock Exchange. Notably, asset managers such as China Asset Management and Harvest Global Investments have taken the lead in offering these ETFs to both retail and institutional investors.

The introduction of crypto ETFs in Hong Kong is a strategic move to reestablish the city as a global financial hub after years of pandemic-related challenges. Despite a slow start, with lower trading volumes than initially anticipated, industry insiders are optimistic about the long-term potential of Hong Kong's ETF market. The city's proactive stance on crypto regulation, combined with its well-established financial infrastructure, positions it to compete with other global centers like the U.S. and Europe.

## 3.2. Australia: Growing Interest in Bitcoin ETFs

Australia, too, has seen significant progress in the adoption of cryptocurrency ETFs. The Australian Securities Exchange (ASX) approved its first Bitcoin ETF in mid-2024, and Monochrome Asset Management launched a spot Bitcoin ETF in June. The Australian crypto market is poised for growth, with predictions that spot crypto ETFs could attract billions in capital over the coming years. The introduction of regulated crypto products is expected to appeal to Australia's robust pension market, particularly self-managed superannuation funds.

This development follows similar moves in the U.S. and Hong Kong and reflects Australia's growing appetite for digital asset investments. The country's regulatory framework for crypto is seen as more lenient compared to other regions, which could drive further adoption of Bitcoin and Ethereum ETFs.

## 4. Market Dynamics and Investment Trends

#### 4.1. Institutional Investment in Bitcoin and Ethereum

Institutional participation in crypto ETFs has surged in 2024, driven by the SEC's approval of Bitcoin and Ethereum ETFs. BlackRock's iShares Bitcoin Trust (IBIT) stands out as a prime example, surpassing \$1 billion in assets under management within just one week of trading. This rapid growth highlights the pent-up demand for regulated financial vehicles offering exposure to digital assets. Similarly, Ethereum ETFs are expected to attract billions in institutional capital, particularly from financial advisers and wealth managers seeking diversified exposure to cryptocurrencies.

Moreover, the growing acceptance of Bitcoin and Ethereum as asset classes has prompted major financial institutions like JP Morgan and Wells Fargo to disclose their investments in these ETFs. These disclosures mark a significant turning point for traditional finance's engagement with digital assets, signaling broader acceptance and integration into mainstream portfolios.

## 4.2. The Rise of Arbitrage Trading and Market Liquidity

The introduction of Bitcoin and Ethereum ETFs has led to a surge in arbitrage trading, a strategy where traders exploit price differences between spot and futures markets. This type of trading has contributed to an 80% increase in open interest on the CME Bitcoin futures market since January, with similar trends expected for Ethereum once its ETFs begin trading. Market makers like Wintermute have announced their involvement in providing liquidity for these ETFs, particularly in regions like Hong Kong, where liquidity remains a key challenge for institutional investors.

As ETFs continue to attract institutional interest, the market is expected to see greater liquidity and reduced price volatility. However, this depends on the ability of market makers to manage large trades without significantly impacting prices.

As the market matures, these products are expected to play a crucial role in bridging the gap between traditional finance and the digital asset economy, paving the way for further innovation and growth in the years to come.



## 6. Expert's Insights



**Aram Mughalyan**Co-Founder at Solidate

1. How do you see the approval of Ethereum ETFs impacting institutional adoption compared to Bitcoin, given Ethereum's broader utility and developer ecosystem?

The approval of Ethereum ETFs is likely to accelerate institutional adoption significantly, but in a different manner than Bitcoin. While Bitcoin is often seen as a store of value, Ethereum's broader utility—especially in decentralized finance (DeFi) and smart contracts—provides institutions with more diverse use cases. Ethereum's robust developer ecosystem and large number of active projects, from NFTs to enterprise blockchain solutions, give it a unique edge.

In your opinion, what are the key factors driving increased institutional interest in Ethereum, and how might this affect its long-term position in the cryptocurrency market?

Institutional interest in Ethereum is being driven by its utility in real-world applications, such as decentralized finance (DeFi), tokenization, and enterprise use cases. Ethereum's ability to facilitate smart contracts and decentralized applications (dApps) sets it apart from Bitcoin, which primarily serves as a store of value. Additionally, Ethereum's move to proof-of-stake, which is seen as more energy-efficient and scalable, has further increased its attractiveness.
